The nominated partner for the partnership is responsible for sending the Partnership Tax Return to us and for making any appeals against penalties. We do not know if your client is the nominated partner.

If your client is the nominated partner for the partnership, please fill in the enclosed form 'SA670 Confirmation of nominated partner' and send it back to us with the appeal.

If your client is not the nominated partner for the partnership, please ask them to contact the nominated partner. If they want to make an appeal they should send it to us with the completed form SA670.

Until we hear from you or the nominated partner, we will assume that your client is not the nominated partner and that the nominated partner does not want to make an appeal. If that is the case, the partners will have to pay their penalties if not already paid.

Go Paperless

We can send you some letters online rather than by post. Go to your online account to see what letters we can send and go paperless. To do this, go to www.gov.uk/log-in-register-hmrc-online-services and login to your account then select the option to go paperless. You can also use this web address to register for an online account.

Please remember that if you want to send your 2025 Self Assessment Tax Return on paper, the deadline is 31 October 2025. If you choose to do it online, you have until 31 January 2026.
